- Via email, please RE-SUBMIT an essay you wrote for a previous year's scholarship submission. The Robinson family and I would like to consider these as well.
- **Nominees are due by Sun., May 19 by 9:00 p.m. via email!**
- The nominees will be forwarded to Alton & Rebecca Robinson. The Robinsons and Ms. April will select the scholarship recipient.
- The Morgan L. Robinson Scholarship winner will be announced at Spring Recitals.
- The \$1,000 scholarship money will be transferred from the *gofundme* account to the Tumble 'N Dance *DanceWorks* account of the scholarship winner after accepting their 2018-19 Competition Dance Team Placement.. All scholarship money must be used for dance related fees associated with being a competition dancer at Tumble 'N Dance for the 2018-19 Season. The scholarship money cannot be redeemed for cash by the scholarship recipient.
